

**INDEMNIFICATION AND RELEASE OF CLAIMS:  
POLICY JLIB STUDENT DISMISSAL PRECAUTIONS**

**DIRECTIONS:** *This Indemnification and Release of Claims shall be signed by the parent/legal guardian at the school (or, in the event a parent/legal guardian cannot come to the school, shall be notarized and sent in to the school – see page 2) and shall be considered the written request for early release under School Board Policy JLIB – Student Dismissal Precautions, which provides: “No student shall be permitted to leave the school grounds during the school day without the principal’s or designee’s prior approval based upon a written request from the student’s parent or legal guardian.” A new request must be filed with the school each academic year.*

\_\_\_\_\_ (initials) I shall be solely financially responsible for paying such defense attorney’s fees and costs and any monetary judgment arising out of such lawsuit.

\_\_\_\_\_ (initials) BY SIGNING THIS FORM, I AM GIVING UP MY CHILD’S RIGHT AND MY RIGHT TO RECOVER FROM THE ORANGE COUNTY SCHOOL BOARD, AND ITS BOARD MEMBERS, EMPLOYEES, OR AGENTS, IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO MY CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE EARLY RELEASE OF MY CHILD.
